Governance:  1. Teacher Salary and Benefits Review:  Eddie Castro and Marti Dodson explained the recommended adjustment to pay based on the LAUSD and other comparable local school districts.  Our schools have always offered teachers a competitive salary. The salary table was prepared by E.Castro and M.Dodson. It was emphasized that we must consider the shortage of teachers nationwide.  The salary table already include a 3% annual increase. It was discussed and decided that there be an increase to the teacher annual salary table by an additional 6%, for a total 9% pay increase as of academic year 2023-2024.  Will revisit the benefits package for the Academic year 2023-2024, that includes health insurance benefits.  The salary tables for the non-credentialled instructional aids/staff were also reviewed. This will be further reviewed and brought up again at the next board meeting.  MOTION  B. Stotzer made the motion to increase the teacher salary table by 6% for this coming Academic year 2023-2024.
